ORDER:

In the G.O. 1st read above orders were issued permitting the Osmania University, Hyderabad to conduct the State Level Eligibility Test (SLET) for the candidates in the Telangana State, which will make them eligible for applying for recruitment to Assistant Professors / Lecturers by the direct recruitment or by promotions, in the Universities / Govt. Degree Colleges, Aided Degree Colleges in the Telangana State, as per the University Grants Commission Regulations, 2009, since the University Grants Commission had already accorded accreditation to Osmania University, Hyderabad, for three years i.e. from May, 2013 to May, 2015.

- 2. The Secretary, TSCHE in his letter 2nd read above has stated that, as per present accreditation of UGC has expired w.e.f. May, 2015, the University proposed to obtain fresh accreditation of UGC for the period hereafter to conduct the SET by the Osmania University and also proposed to appoint **Prof P. Yadagiri Swamy**, Dept. of Chemistry, University College of Science, Osmania University, Hyderabad, who is continuing as **Member Secretary**, SET in place of Prof. B. Rajeshwar Reddy, who was appointed earlier as Member Secretary vide G.O.Ms No.155, HE (CE) Deptt., dt.9.12.2011 and requested to seek approval of the Government in this regard and to issue necessary orders on the following:-
 - (i) To identify Osmania University, Hyderabad, as the State Agency to conduct the State Eligibility Test (SET) for the Candidates of Telangana State who will be eligible for recruitment for Asst. Professors/Lecturers by Direct recruitment or by promotion in the Universities/Govt. Degree Colleges, Aided Degree Colleges in the State.
 - (ii) To appoint representatives of the Government to the Steering Committee and Moderation Committee, as per their composition stated in G.O.Ms No.155, HE (CE) Deptt., dt:9-12-2011.
 - (iii) To approve the proposal of the Registrar, Osmania University to appoint Prof. P. Yadagiri Swamy, Dept. of Chemistry, Osmania University, Hyderabad as Member Secretary, SET and
 - (iv) To permit Vice-Chancellor, Osmania University, Hyderabad to take further action in the matter for conducting SET-2016.

- 3. The Registrar, OU in his letter 3rd read above has requested the Government to constitute Steering Committee and Moderation Committee to obtain accreditation from the University Grants Commission, New Delhi for conducting of State Level Eligibility Test (SLET),2016.
- 4. After careful examination of the matter and in continuation to G.O. Ms No.155, HE (CE) Deptt., dt:9-12-2011, the Government hereby appoint the Chairman, Member Secretary and one representative of the State Government on the Steering Committee and Moderation Committee as mentioned below:-
 - (i) The Vice Chancellor, Osmania University, Hyderabad as Chairman of the Steering Committee and Moderation Committee.
 - (ii) Prof. P. Yadagiri Swamy, Dept. of Chemistry, Osmania University, Hyderabad as Member Secretary to the Steering Committee and Moderation Committee.
 - (iii) The Commissioner of Collegiate Education, Telangana State, Hyderabad as State Government's representative on the Steering Committee and Moderation Committee.
 - (iv) The Vice-Chancellor, Osmania University, Hyderabad shall take further action to constitute the Steering Committee and Moderation Committee with other members.
- 5. The Osmania University, Hyderabad is identified as the State Agency to conduct SET, 2016 and the Vice-Chancellor, Osmania University is thus permitted to take further necessary action for conducting SET-2016 for Telangana.
